President's Update

Hello to my friends and neighbors. I'm pleased to share some exciting news for the community.

Grant from the Pittsburgh Partnership for Neighborhood Development (PPND)

PPND has approved a grant in the amount of \$25,000 for a collaboration between CNNC, Perry Hilltop, California Kirkbride, Children's Museum and the New Hazlett Theater to find ways to work together to enhance our communities.

PPND nurtures sustainable community growth with expertise and early strategic capital. PPND asked for applications by combined neighborhoods and non-profit stakeholders to recognize needs and then find ways to work together in making the necessary changes. The PPND grant provides \$25,000 to hire a professional to work with the granted communities and explore the success potential. We felt that our application, combined with the worthy communities and partners mentioned above, made us a strong candidate. We were not alone in our beliefs and this grant represents a vote of confidence in the individual neighborhoods, institutions, and relationships we have all helped to build."

CNNC Board Member Barb Talerico and consultant Tom Hardy spent many hours putting together the application and a compelling story to support it. Kudos go to them and the outstanding partners we are honored to work.

The lasting and positive implications for all North Side communities due to this grant cannot be overstated. The opportunities before us did not happen instantly. The work of many over the course of a number of years has created enormous momentum. In the past four years, the Central Northside Neighborhood Council has had the good fortune to work with committed and visionary individuals to transform our community.

To put this in perspective, just four years ago in 2008 . . .

The entire **Garden Theater Block** was threatened to be demolished. With the hard work of many committed individuals, the GTB will soon have a new lease on life and will be transformed into a destination spot for people all over the city.

North Avenue was one boarded up building after another. Now we have Crazy Mocha, Deli on North and more on the way.

The Central Northside had no plan for the future agreed upon by the community. Now we have a **Community Master Plan** that was led by CNNC and supported by the community, and it is now serving as our roadmap into the future.

Federal Street was full of abandoned structures and boarded up homes. Now there are new homes filled with individuals and families of all kinds.

CNNC would like to spotlight a few of the people who donated countless hours to make this happen:

Bill Buettin, an incredibly intelligent banker who charted a course for development.

Kirk Burkley, an attorney with development experience, political know how and the courage to take on tough but needed tasks, like, after 30 years, finally creating a

Safety Update

CNNC Launches Off-duty Police Patrols for Summer Patrol

The CNNC Safety Committee is launching a plan in which off-duty police officers will be hired throughout the summer months to patrol various parts of our community that have a history of drug and violent activity. This initiative is likely to begin in June. We will be seeking funding from both residents and the CNNC. More information will be shared in the near future.

Residential Parking Permit Program

A process has been initiated for creating a new permit parking district within the Central Northside Neighborhood. This program, if approved by the community, will help secure on-street parking for residents. As of June 1st, there will be a 90-day period of review and petition. Development Update

Federal Hill Housing

This project will move forward with the next phase of for-sale homes on the east side of Federal Street with construction beginning in June. The seven units that make up the next phase of development follow the current phase in which all but one of the twelve units has closed—the final buyer should close in the next month. Please join CNNC and our development partner S&A Homes in welcoming our new neighbors to the community.



Other Federal Street Progress

The former Toulas Restaurant at 1108 Federal St. is being renovated by Bill Barron. The first floor will feature a Mexican restaurant and the upper-floor will have an apartment. Occupancy is expected by the end of this summer. The CNNC facilitated this development by obtaining site control and arranging for a portion of the financing.

Steve's Hot Dogs at 1110 is renovating the front of their building façade. CNNC helped to arrange a small matching grant via the Northside Leadership Conference and Rivers Casino.

Garden Theater Block

We have great news to report in that the second lease for the project has been signed—and it is for

the Garden Theater! Spencer Warren, former operator of the Firehouse Lounge in the Strip District will bring his talents to help anchor the development of the Garden Block with a restaurant & bar. Mr. Warren joins Nakama, who has signed a lease for the Masonic Temple, as businesses that have committed to this project. Developer Wayne Zukin and Allegheny City Development are working on additional lease commitments for the other buildings in the block.

Stabilization work on 1113-1115 Federal St continues. This work is expected to be completed in June. The new temporary fencing in front of the Masonic Temple and Garden Theater has been installed so that the old plywood can be removed to expose the original openings. This will allow the architect to complete the plans for these buildings.

Property Reserve Program – Mini RFP

CNNC approved proposals to purchase certain properties that CNNC controls in the City's Property Reserve. The proposals were in response to the Request for Proposals (RFP) for developers or homeowners that were advertised on CNNC's website for several months. The approved proposals were from Todd Meyer (250 & 248 Alpine, 104 & 108 Sampsonia) and Frank Quinn (1525, 27, 29, 31 Saturn). The next step is to complete the paperwork and transfer the properties. Saving these structures from the wrecking ball and returning them to the tax rolls helps us create a more vibrant neighborhood. CNNC has recently posted a list of the properties it controls in the Property Reserve Program on its website: www.cncn-pgh.org (located on the Development Committee Page under Member Resources). There are only two properties not yet spoken for: 1532 and 1534 Federal Street.
