#### Introduction

The regular monthly meeting for the membership of the Allegheny City Central Association was held on Monday, January 13, 2014, at 7:00 p.m. in the auditorium of Allegheny Traditional Academy, President Steve Adams being in the chair and Secretary Arthur James being present.

The minutes of the last regular monthly meeting on II/I8/I3 were not distributed beforehand, and so were not approved. They will be distributed before the February meeting.

### **Board Elections**

Steve Adams reported on the upcoming board elections

- Board elections will be held in May.
- Per the bylaws, we can form an Elections Committee. The committee is to be 5 members, 2 of which must be board members who will not be running.
  - O Deena Kelly and Brian Kaminski volunteered to be on the Elections Committee.
- In February, we will announce that nominations will be taken.
- Nominations will be taken in March and April.
- The board has need for people with the following skills:
  - O Familiarity with taxes and audits. Ability to interface and manage the accounting service we have been using.
  - O Grant writing we're probably missing out on possible funding sources.
  - O Security camera management we've installed some cameras, but could use someone to ensure that they're running and accessible.

### **Bylaws**

At the II/I8/2013 meeting David Shlapak moved that

To reflect the membership's instruction to change the organization's name, it is moved that all occurrences of "Central Northside Neighborhood Council" shall be replaced with "Allegheny City Central Association." All occurrences of "the Council" shall be replaced with "the Association." All occurrences of the name "Central Northside" shall be replaced with "Allegheny City Central."



The process for changing the bylaws is as follows:

- Provide 30 days notice of intended changes. Notice of the above motion was given at the I0/2I/20I3 meeting.
- Move to make the changes and obtain a 75% majority vote. This occurred at the II/I8/20I3 meeting
- Make the same motion at the next membership meeting and obtain a simple majority vote, which is this 01/14/2014 meeting

The motion was repeated, and a vote was taken. It passed unanimously. The bylaws will be changed per the motion.

#### **Announcements**

- Henry Reese invited people to participate in his project with Oliver Lake. Oliver Lake will talk with people about
  living on the Northside and use that to compose music and possibly a theater piece. Oliver Lake will do a two week
  residency. The first meeting will be on January 24th.

# Treasurer's Report

David Shlapak presented the Treasurer's Report.

## **Development**

Tom Hardy reported on development topics.

- RFP for Residential Developers
  - o Gave a slide presentation of the Development Committee's recommendations.
    - Received four proposals.
    - Recommendation Award Arctecon exclusive option to develop 3 owner-occupied homes on the following properties: 212, 214, & 216 Alpine and 211, 213 & 215 Carrington.
    - Recommendation Award Todd Palcic exclusive option to develop large lot at I07 Alpine (23-F-352) subject to a review of plans.
    - Recommendation Award 1511 Arch St. (23-F-328) to October Development which will be part
      of next phase of his housing development. October Development owns adjacent property.
    - Recommendation Award 223 Alpine St. (23-F-282) to Deena Kelly as a side yard for her residence at 226 Jacksonia. Parcel is landlocked and can't be aggregated with other properties for a larger development.
    - 8 of 27 parcels in the Property Reserve would be awarded.
    - Awardees must begin work within 9 months of closing, and complete work 12 months after that.

Andrew Wickesberg moved that

The General Membership accept the recommendations from the Development Committee and Board and award properties from the RFP to Arctecon, Todd Palcic, October Development and Deena Kelly as presented.

The motion passed unanimously.

- Welcome Neighbor to Neighbor
  - Leslie Ward, along with a number of volunteers, has done a great job with the Welcome Neighbor to Neighbor program.

  - They meet with the residents and provide them with a packet of resources and information about the neighborhood.
  - O Leslie would like to pass her role on to somebody else. Any new volunteers would be welcome.
  - O Also, if anyone is aware of new neighbors, please let them know about the program.
