ANNOUNCEMENT**

The Pennsylvania Department of Transportation (PennDOT) in cooperation with the Federal Highway Administration (FHWA) are pleased to invite you to attend a Open House Public Informational Meeting being conducted to inform you about the SR 4084, Section A04 East Ohio Street Improvement Project.

The proposed project includes roadway reconstruction and associated bridge preservation work within the following limits: East Ohio Street (SR 4084) from Nash Street to Chestnut Street including the bridge over SR 0279, Chestnut Street at the intersection with East Ohio Street including the bridge over SR 0028, SR 0028 northbound (NB) on ramp from Chestnut Street including the bridge over SR 0028, SR 0028 southbound (SB) off ramp to Chestnut Street, East Street from East Ohio Street to the East Street overpass above SR 0279, Madison Avenue from East Ohio Street to the East Street overpass above SR 0279, and the ramp connecting SR 0279 NB to SR 0028 NB including the bridge over Anderson Street. Other project features include new curb ramps at the signalized intersections, repairs to the existing retaining wall supporting the grade separation between SR 0028 and the Chestnut Street off ramp as well as upgrades to the existing traffic signal systems, signing, and pavement markings. Additionally, the Department is evaluating potential bike lanes on East Ohio Street.

During the Open House Public Meeting, the project team will be available to present project details, the anticipated construction schedule, and proposed detour routes as well as answer any questions or discuss any issues or concerns you might have. Pursuant to Section 106 of the National Historic Preservation Act, PennDOT is seeking public input on the identification of cultural resources and the project's effect on those resources.
