 - A. 2014-2015 Audit
- Tom Hardy reported on the audit. The audit is available on-line. Edie York is our new auditor/accountant. Hardy explained current funding stream has wound down (ACPO) because the neighborhood has a more diverse income bracket than we once did.
- V. Development Update
 - A. Garden Theater Block, Guests—TREK Development Group & Q Development
- Bill Gatti Update

TREK was awarded a zoning variance in the fall that was Appealed by 2 neighbors. One dropped out and one remains. Trek is trying to meet with the individual to talk but has not had any luck. There was a pretrial hearing in December with Judge James. The Appellate's attorney was present, and the Jan 7 appeal was presented. Gatti feels that the Judge is leaning in "our" favor

Gatti thinks that we will be hearing something within the next 30 days, and there is the possibility of additional appeals even after the Judges decision. Trek has acquired the Garden Theater, and URA refurbishment of the Garden Theater Sign is moving forward. TREK continues to field inquiries from possible Restaurants and commercial groups. On the subject of the Bradbury, TREK considered moving forward with that but it proved to be too difficult for the investors without the rest of the block. At present, the URA owns all buildings other than Garden Theater. Buildings are in terrible shape. Trek has secured parking for the apartments from the Parking Garage owner on Federal Street.

• Glenn O. asked Gatti to move forward with part of the block to ease the construction noise and dust that might be a nuisance to City of Asylum.



- Gatti responded that his investors will not commit to any construction at this point.
- Henry Reese responded that he knows that it isn't easy to get funding as one would think and is ok with how Trek is handling it. City of Asylum was awarded grants for construction.
- Susan Larkin made a motion to get neighborhood lawyers together to see if we as a community group have standing and can sue the appealer. Deena Kelly seconded the motion. Motion passes. One "no" vote –David Charlton
- Glenn asked that Steven Pascal be given notice that we are investigating suing him. No discussion on this suggestion.

VIII. Sampsonia Green Alley Project Update & Feedback

Tim Nuttle presented the ongoing Community Plan for the Central Northside storm water plan. Alcosan's current plan is for 3-4 billion gallons of runoff to be treated by gray infrastructure, including new treatment

tunnels and plants Redirection of storm water through Green Infrastructure is encouraged, and to that end the neighborhood has developed a conceptual design. This would be the first green alley project in Pittsburgh, and would serve as the model for elsewhere in the city.

The next step is for the ACCA to support the project with the city.
