# Conservatorship

#### Federal Hill – Residential RFP

Greg Spicer reported that the CNNC Board of Directors voted to approve the new district per the neighborhood boundary, including empty lots.

# a. BRAT Force - Greg Spicer, President (Randi Marshak, BRAT Chair, absent)

## Garden Theater Block (GTB)

One of the difficulties of marketing the space to tenants is the current state of the buildings. Therefore, there is a plan to develop 6 West North Avenue, which used to be a single family home, and that the developer will use as their offices.

## **GTB Tenant Recruitment**

East End Food Co-Op continues to be interested but is moving cautiously. We believe that the EEFC is close to signing on as the anchor tenant.

## Casino Funds – Jan Meyer, NSLC Representative for CNNC

\$40,000 has been awarded from the Casino funds for work on Toula's and the Federal Hill Street Face Program, as well as a Federal/Henderson study for a Gateway Welcoming area.

Jan Meyers and Neil Parham, Election Committee Chairs, recruited volunteers to participate on the election committee. Jan reviewed the bylaws and noted that nominations will be taken only at the April membership meeting.
