Announcements/General Discussion:

Minutes from October 11, 2021 General Membership Meetings:

Rick Krist from Monterey Pub:

- Rick is working with the Northside Community Fund to obtain a loan:
 - The loan will provide gap funding for future projects and paying back the developers
 - o Rick is looking to get better equipment and provide staff training
 - Rick is asking for a letter of support from ACCA for the business and the loan
- Greg Spicer made two points about two unresolved issues:
 - One issue regarded the smoking ban. Smoking is allowed in the front and back of the Monterey Pub

Rick said that he is aware of the issue, he is open to suggestions, but must follow the law



- Greg also pointed out that three nights last week, there was a ruckus coming from the bar. He feels the last call at midnight, with food being stopped at 10:00 pm, allows for people departing the Pub to make noise outside.
- Beth is moving in the house next door and is open to working with the pub to make the pub the best it can be.
- Beth motioned that the ACCA write a letter of support, with an understanding that the neighborhood and the pub will work together regarding noise or other issues. Motion passed.

Lynne Weber from Arch Court:

- The board oversees the management to make sure things are well maintained

- Lynn stated that this is a good time for the board to re-engage the ACCA
- Councilman Wilson offered support through the city
- Joan Kimmel offered one of their concerns is to make sure Arch Court can continue with a stabilized board. With so many good, smart, and young people in the neighborhood, the Board wants to connect officially in a more formal way so that they can be assured that Arch Court continues with good oversight and management.
- Vince motioned to form an Affordable Housing Committee within the ACCA. Lynne seconded. Motion passed.
