# **Greg Ramsey for Garbage Olympics 2022**

- Greg invited anyone who is interested in participating in Garbage Olympics 2022 to meet at 316 Jacksonia Street on Saturday, September 17. Trash collection is from 9AM-11AM.

- The team's name is 'Northside Irregulars.' It is listed on the Garbage Olympics website as 'Central Northside.'



## **Lynn Weber for the Affordable Housing Committee**

- The Affordable Housing Committee has had two meetings.
- The goal of the committee is to maintain the affordable housing that we have in the neighborhood and explore other options.
- Lynn introduced Lena Andrews who is the Head of Real Estate for Action Housing in Pittsburgh.
- Action Housing is working with the Widow's Home at 308 North Taylor Avenue.
- Action Housing has been around for 65 years. They have about 80 million dollars in affording housing.
- Lena explained what affordable housing is considered: 30% of a household's income goes towards housing.
- There is a need of 17,000 new units to meet housing demand.
- Action Housing Builds to own for a long time.
- Widow's Home has a total of 24 units: nine one bedrooms, and fifteen two-bedroom townhouses.
- Widow's Home is currently owned by Pennrose and is transferring ownership to Action Housing. Current affordability restrictions <60% AMI (approximately \$37,000 for a onebedroom household).
- Many residents are paying more than 30% of income in rent/utilities.
- Maintaining and investigating in the YMCA
- Vince asked if Action Housing is more likely to acquire housing or build housing:
   This was their first preservation acquisition. Arch Court and West Commons were mentioned to Lena.

#### Faith Mudd for Councilman Wilson

- Faith did not have any announcements
- Home at the Corner of Armandale and Saturn
  - Maggie mentioned the house on the corner of Armandale and Saturn is being hit by vehicles
  - Katie Minor moved to the house in April 2021 and has had her house hit monthly and is asking for help
  - Maggie suggested sending letters to the Council Members to organize a meeting with DOMI to assess the area
- Jefferson Recreation Center
  - Vince asked if there has been any movement in redeveloping the Jefferson Recreation Center. No update was able to be provided.
  - Faith added that she had gotten word from Councilman Wilson that Jefferson Rec Center isn't part of Councilman Wilson's district yet. It will be on January 1<sup>st</sup> after redistricting. Right now, it is part of Councilman Lavelle's district.

- Request for Letter of Support for Allegheny Commons Funding
  - Pittsburgh Parks Conservancy is asking ACCA for a letter of support in a request for a million dollars towards Segment B of the North Commons Promenade Project – from Federal Street to Arch Street
  - o Lynne Weber made the motion, Beth seconded. Motion passed.
