Erin Tobin from Pittsburgh Parks Conservancy

- The Pittsburgh Parks Conservancy team will be meeting with site architects and Department of Public Works in Allegheny Commons Park to discuss the next phase of the North Promenade Project that runs from Federal Street to Arch Street. This phase of the project includes all the same improvements that were done in Segment A, newly planted trees, newly paved pathways, installation of light posts (there is currently no lighting in this section of the park) and placement of benches and trash receptacles.
- Park events are wrapping up for the season, but there are still a few Allegheny Commons Park events to enjoy in October.



Rachael Heisler from Affordable Housing Committee

- The Affordable Housing Committee is moving forward in formulating a plan for a Housing Forum. More information will be shared as details are finalized.

Faith Mudd for Councilman Bobby Wilson's Office

- Erin asked Faith about the status of the lights in Allegheny Commons Park.
 Faith said that the lighting will be a Department of Public Works project (not Pittsburgh Parks Conservancy) and that a new electrical panel will be installed sometime in November. Allegheny City Electric, the City's electric contractor, is waiting for the panel to arrive and it will be installed in the park adjacent to the Aviary driveway. This source will power the lights in the western part of the park around the lake and West Commons near Gus and Yia Yia's.
